Dear Senator Allard:

I write in response to your letter dated September 6, 2006 regarding the Rocky Mountain Low-Level Radioactive Waste Compact Board's (Rocky Mountain Compact) efforts to expand its jurisdiction to include all types of naturally occurring radioactive material (NORM) and technologically-enhanced NORM (TENORM).

Based upon your interpretation of the Low-Level Radioactive Waste Policy Amendments Act of 1985 (P.L. 99-240) (LLRW Act), which approved the efforts of Colorado, Nevada, and New Mexico to create an independent regional agency to oversee the disposal of radioactive waste and regulate the resulting interstate commerce implications, I understand you are concerned that the Rocky Mountain Compact has overstepped its jurisdictional limitations and violated the Commerce Clause of the Constitution.

If correct, congressional action may be warranted. The questions specifically posed by your letter may have implications for matters of interstate compact that fall within the jurisdiction of the Judiciary Committee, as well as constitutional matters implicating the Committee's jurisdiction. As such, my staff will launch an inquiry into the actions of the Rocky Mountain Compact.
