Dear Ms. Bacon, Mr. Cruz, Mr. Morris, and others:

Thank you for Ms. Jennifer Bacon's email of August 14, 2024. In it, she referred to the "Supplemental Response" letter from Mr. Anthony Cruz of May 31, 2024. She implied that Mr. Cruz's letter was the last and final communication that OIG would be providing on the

subject of OIG's investigation of OIG Complaint 23-0160-C. However, Ms. Bacon omitted any reference to my reply letter of June 9, 2024 (See below), which ...

- Rebutted to OIG's claims of invasion of personal privacy
- Answered OIG's questions from February 16, 2023
- Observed that no response from any part of DOE, whether it be, ETEC, EM, OIG or the FOIA Office, has attempted to address the specific allegations of OIG Complaint 23-0160-C.
- Requested that OIG provide the basis, the rationale, the analysis, and the evidence to conclude that *"no further action is warranted."*
- Observed that little relevant information about OIG's investigation was provided in the attached documents to Mr. Cruz's May 31, 2024, letter.

I am therefore puzzled why OIG believes its job is completed.

Mr. Cruz's earlier letter of March 26, 2024, had provided evidence that OIG had requested a response to OIG Complaint 23-0160-C, from Mr. William White (former Senior Advisor to the Office of Environmental Management (EM)) on March 16, 2023. Note the year was 2023. On July 14, 2023, Mr. Timothy Harms sent EM's complaint response to OIG (identified as Document 4). It was over a year ago that OIG possessed EM's response to the complaint, but OIG has hidden behind arcane bureaucracy to prevent me seeing it. Mr. Cruz's letter stated that OIG had requested EM's approval to release Document 4 on an unknown date.

My August 12, 2024, telephone conversation with DOE FOIA liaison, Mr. Alexander (Chris) Morris revealed that he was unaware of the details of the original complaints but was aware of the existence of the infamous Document 4. He did not know why I had not been provided Document 4. He did not know if a release approval for Document 4 had been requested and did not know whether Document 4 release approval had been provided by EM. He committed to look into it!!!

Hopefully, this accurately summarizes the current status of this 20-month effort.
